 - Sealcoat: Clay furnace 3.2 miles, Fullingmill Road 3.2 miles for a total of 6.5 miles.
 - Scratch coat: Fullingmill 18'x1000', Lake Ext 4' x 300' Both Sides & 18'x550' full width. Other roads discussed were N. Hassel has to have prime and seal coats though the Joint Sealcoat Bid program. Roads discussed but no decisions made on were Charleston in need of repair to lanes. McCullough Road between Daily and Charleston and Line Road.
