A motion was made by Mr. Settle to approve the reconciliations on all accounts for the month of July 2020. Seconded by Mr. McCullough. Motion passed with 3 yes votes

Public Comment Period:

Mrs. Marlene Gilliland of 21 Winner Road, Hermitage, PA asked if someone had checked on her complaint regarding her neighbor. Mr. Burkett advised Mr. Gilliland that although he sees her concerns it does not violate any ordinance.

Mr. Garth Falkner of 7900 Lamor Road, Mercer, PA inquired as to whether or not William Dunn resignation had every been accepted by the board prior to the appointment of Mr. Settle. Mr. Burkett assured him that the resignation had been accepted. Mr. Falkner also inquired if the township was hiring a replacement for Officer Ealing. Mr. Settle advised that the Chief of Police was actively looking for a replacement.

Mr. Ken Swartz of 2381 Lake Road expressed concerns regarding neighbors with property line dispute and a noise problem in the area. Mr. Burkett advised Mr. Swartz that the property line dispute was a civil matter, and in that the Township Police Department had already responded regarding the noise complaint that matter would be left to the Police.
