Motion made by John Burkett to not accept reservations for rentals for the hall or lodge for the months of February and March 2021 with the exception of the Fair Auction in March. Seconded by Richard McCullough. Motion passed with 3 votes.

Motion made by John Burkett to accept the December additions and exonerations for the 2020 Tax Duplicate Per Capita Exons, with 12 in the amount of \$60.00. Seconded by Richard McCullough. Motion passed with 3 yes votes.

Discussed setting up Audit for Tax Collector for the years 2019 and 2020. Barbara Wolfe will contact the auditors to make schedule for the audit.
