The monthly meeting of the Jefferson Township Board of Supervisors was called to order by Mr. McCullough on April 10, 2023, at 7:00pm at the Jefferson Township Building, 7407 Lamor Rd, Mercer, PA 16137.

The Pledge of Allegiance was recited and Roll Call was taken at the reorganization meeting ahead of regular meeting. In attendance were Supervisors John Burkett, Richard McCullough, Tyler Angermeier and Secretary/Treasurer Rachel Nickel, along with the public sign in sheet.

A motion was made by Mr. McCullough to approve the minutes from March 13, 2023 Supervisors Meeting. Seconded by Mr. Angermeier. Motion passed with 3 yes votes.

Motion was made by Mr. McCullough and seconded by Mr. Angermeier to pay the following payables for March 13, 2023 through April 10, 2023. Motion passed with 3 yes votes.

His question was do they raise the taxes with tax assessment. Mr. Burkett advised him we would talk with the township tax collector and give him a call.

Ms. McWilliams of Highland Rd. asked to use the township hall for Primary Election Day May 16, 2023.

Hawbaker Inc. - \$ 116,950.00, Frank Martuccio Asphalt & Paving Inc. - \$106,900.00. Awarded bidder went to Shields Asphalt Paving for \$90,100.00. Seconded by Mr. Angermeier. Motion passed with 3 yes votes.

A motion was made by Mr. Burkett for Mercer County 2023 Hazard Mitigation Plan Resolution 6 of 2023. Seconded by Mr. Angermeier. Motion passed with 3 yes votes.

Mr. Burkett discussed the need for the police to get a new computer police system its around \$30,000.00 for system and \$10,000.00 for new server. Chief Lockard is to get quotes and vote on at next months meeting.
