The monthly meeting of the Jefferson Township Board of Supervisors was called to order by Mr. Burkett on August 14, 2023, at 7:00pm at the Jefferson Township Building, 7407 Lamor Rd, Mercer, PA 16137.

The Pledge of Allegiance was recited and Roll Call was taken. In attendance were Supervisors John Burkett, Richard McCullough, Tyler Angermeier and Secretary/Treasurer Rachel Nickel, along with the public sign in sheet.

A motion was made by Mr. McCullough to approve the minutes from July 10, 2023 Supervisors Meeting. Seconded by Mr. Angermeier. Motion passed with 3 yes votes.

Motion was made by Mr. Angermeier and seconded by Mr. McCullough to pay the following payables for July 10, 2023 through August 14, 2023. Motion passed with 3 yes votes.

A motion was made by Mr. McCullough to approve the reconciliations for July 2023. Seconded by Mr. Angermeier. Motion passed with 3 yes votes.

E & P Sanitation from Sandy Lake, PA. questioned the garbage contract. He could not produce the correct paperwork for the garbage bid package. Mr. Burkett explained how the township ran out of time and needed to put a contract in place for the township residents.

Townes Telecommunications, Inc. sent a letter along with pricing and a coverage map for broadband services. Mr. Burkett read the letter and would like to contact them to hear more about this.

Administrative Actions:

Mr. McCullough made a motion to accept the amended Municipal Residential Refuse Collection / Disposal Service Bid Contract from Tri County Industries, Inc. Seconded by Mr. Burkett. Passed with 2 yes votes and 1 no vote.

A motion was made by Mr. McCullough to approve the Per Capita Additions 1 at \$33.25 and the Per Capita Exons 21 at \$200.00 and the Per Capita Additions 6 at \$60.00. Seconded by Mr. Angermeier. Motion passed with 3 yes votes.
